

**Sunshine Float for Dreams
Givr Guitar Giveaway
Official Draw Rules (“Draw Rules”)**

Commencing **Wednesday, May 15, 2019** at 12 pm EST and ending **Friday, May 31, 2019** at 6 am EST (the “Draw Period”), registered participants are eligible for the Sunshine Float for Dreams Givr Guitar Giveaway held by The Sunshine Foundation of Canada (“Sunshine”).

How to Enter:

During the Draw Period, individuals (each an “Entrant”) must register to participate in Sunshine Float for Dreams at www.floatfordreams.ca.

The information provided in the registration form will only be used to contact an Entrant who has won a Prize, for statistical purposes, and or for sending Entrants further details about the Float for Dreams event.

All individuals who have registered for Float for Dreams 2019 before May 31, 2019 will automatically be entered into the draw.

Eligibility:

To qualify for the Prize, all entries must be received leading up and during to the Draw Period.

Draw CLOSING: The draw closes at 6 am EST on Friday, May 31, 2019.

Only valid entries will be eligible for the Prize and must be received during the Draw Period. A valid entrant must be registered to participate in Float for Dreams and provide complete and accurate contact information according to the online registration form.
